Perkins Boat Ramp Decal Registration

MUST BE a Belle Isle resident and MUST PROVIDE a valid identification card. Decals should be placed on the left side of the Front Windshield.

Valid from June 1st and expires May 30th - \$50.00. Decal Fees are not pro-rated.

1. Ramps are for launching only, not other recreational uses, including No taking turns of any watercraft, particularly Jet Skis.
2. No launching or recovery from Sunset to Sunrise.
3. No Skiing, Swimming, or fishing from ramp areas.
4. No powering on or off trailers.
5. No running of watercraft engines out of the water, including jet skis.
6. No alcohol at the ramps.
7. All no-wake zones must be obeyed.
8. No parking at Perkins ramp without a trailer or a permit. Parking of watercraft trailers on adjacent streets is also prohibited. Parked vehicles must not block ramp access.
9. There is no parking at the Venetian on-ramp, ramp driveway, or Venetian Park area (including streets).
10. No anchoring or mooring within 100 feet of the ramp.
11. No fueling is allowed at the ramps for any watercraft.
12. Idling at the boat ramps is prohibited.
13. There is no draining, cleaning, washing, repair, or servicing of watercraft at the ramps.
14. There is no bilge pump discharge or drain plugs popping at the ramps or in the water.
15. An adult must accompany persons under the age of 16.
16. No littering or disposing of food or beverages in the water.
17. Perkins Ramp Only- Watercraft must be 22.5 feet long or less. (Exception for pontoon boats to 24 feet)
18. No trespassing on adjacent properties.
19. Dogs must be on leashes.
20. No commercial use for demos or sales or any other commercial use.
21. No vehicles with loud exhaust systems or no exhaust.
22. No spinning of tires or rubber on-ramps.
23. No picnicking or fires.
24. Use by residents or non-residents without a permit may be towed at the owner's expense and a \$150 fine.
25. No profanity or loud music.
26. Be courteous to adjoining neighbors. All applicable noise ordinances must be observed. This is our community; take pride in it! Be aware area is under video surveillance. Your misuse may result in a fine and ban from use.
27. Breach of rules may be subject to a fine of stiff sanction- \$150 and banning the use of ramp and loss of permit.

I certify that (1) I have been provided with a copy of the rules and regulations at the Perkins Boat Ramp, (2) that the area is under video surveillance and failure to comply with the rules and regulations may result in fines and revocation of the permit, (3) that I will protect the water quality of the Conway Chain of Lakes, (4) agree to operate my watercraft safely and courteously, and (5) that my watercraft engine is in good working condition and does not leak fuel or oil.

I, the undersigned, affirm that the information set forth below is correct and agree on behalf of myself and my passengers to adhere to the rules and understand all consequences of misuse.
