Happy Holidays, everyone!

he State of the City of Belle Isle is both positive and promising. This year's challenges with the pandemic, hurricanes, and massive growth surrounding our City have tested us. I am proud of the response by our City Council, City staff, and residents in dealing with these challenges.

As Mayor, my focus is to listen, learn, and lead, so I can amplify the successes we strive for every day. I want to highlight what I believe are:

- The accomplishments
- The progress made
- The goals outlined in the City's Strategic Plan
- Future goals for the year ahead

The City of Belle Isle's budget provides a financial plan that integrates Council goal setting, priorities, and initiatives. The City is very fortunate to have a healthy reserve in the General Fund, but this reserve will not last without additional sustaining revenues added to the General Fund. The Council, Staff, and Budget Committee are committed to identifying sustainable revenue for the future. The Fiscal Year 2022-2023 Preliminary Operating and Capital Budget was submitted with further detail per the City Charter. It is available on the City's website or by contacting City Hall staff.

The City of Belle Isle received approximately \$3.6 million in Federal Stimulus Relief through the American Rescue Plan Act (ARPA). City staff recommended that Council allocate these funds to support stormwater infrastructure, general fund projects, premium pay for first responders, fill staffing shortages, and restore revenue negatively impacted by the pandemic.

Below are notable financial assumptions as well as other positive initiatives:

- No tax millage increases for the 14th year- City Council and City staff continue researching alternative funding sources to achieve this
- Maintains current excellent levels of service to the community
- Carries a 29% reserve in the General Fund as recommended by the Budget Committee
- Start the planning for updating the City's Comprehensive Plan in 2024
- Partner with Orange County on road and stormwater projects

- Approval of Belle Isle Police Department Pay Plan with incremental increases for salary and retirement. The City is competitive with other law enforcement agencies to retain talent. We invest heavily in their training and adoption of our department rigors
- Non-uniform employees continued merit programs and retirement increases.
- The City receives rent from Cornerstone Charter Academy (CCA)
 - The former Bank of America building (6300 Hansel Avenue) purchased by the City was included in the new lease. This expanded the City's property holdings while having the school, our tenant, pay for it via the rent, which will eventually pay the property off over the lease term
 - CCA removed \$8 million in debt from the City by refinancing the 2012 bonds. This allowed CCA to raise a \$52,000,000 bond to expand the campus and heighten programming for students, which benefits families in the community
- Provide a major investment in sidewalk repair and replacement city-wide
- Invest in social media to provide a better platform for communication
- Installed Rectangular Rapid Flashing Beacons (RRFB) on Hoffner Avenue and improved the RRFB on Daetwyler at Seminole
- Expanded our police by adding two police officers for a total of 24
- Transitioned our resident reporting systems to GoGov - Here, you can access City Hall 24 hours a day, seven days a week, from the comfort of your home
- Continue to forecast monthly reporting to Cleargov.com, which displays all City revenues and expenses.
- The Sol Avenue repaying project is nearing completion
- The City Council and Community have worked to defeat harmful growth projects like the one planned on McCoy Road
- The City annexed Sienna Place, which expanded our tax roll, and boundaries and welcomed more residents to the City
- Two named storm preparations and major poststorm clean-ups by City personnel and the FEMA crew
- Migrated Code Enforcement under the Belle Isle Police Department and added a Code Enforcement Officer for a total of 2
- The City Clerk implemented a first-ever brand standard guide to include a modern redesign of all City branding material to provide brand consistency and a more professional public image

- We continue to hold spectacular special events throughout . the year with Spring Fling, Light the Way, and Santa's Sleigh Ride
- We are in the process of procuring additional property to . relocate our police department as well as our city hall in the form of a combined municipal complex
- Swann Beach was completely renovated •
- Labelle Beach modifications have been completed
- City Council preserved the Lancaster House

I am proud of the dedication demonstrated by the City's emergency services, who have adapted to the pandemic's challenges, including during the two recent names storms: lan and Nicole. We salute the determination and commitment of all City employees, City Hall staff, Police Department and Public Works. We depend on you all.

- Tell your mail carrier that your mail should NOT be forwarded.

What can the Planning & Code Enforcement Departments *Do for you?*

The City of Belle Isle investigates and fines violations of city code. The *Code Enforcement* Department is responsible for enforcing city codes...Let the City of Belle Isle know about *code violations* within city limits. Below are some of the most common violations.

Can you match the picture with the Code.

Section 30-73 No parking on or over the sidewalk. Park on the side of the road if able.

30-73 No parking on the grass (prepared surface only, mulch, white rock, or stone pavers). A permit is required for a prepared surface;

10-31 Maintain your property, don't be a public nuisance. Overgrown yards can contribute to pests/bugs.

30-133 No parking of Recreational Vehicles, Motor Homes, and Utility trailers on the front of the property. Only one watercraft trailer is allowed on the front of the property (on a prepared surface).

24-23 Keep the trash accumulation in order and only place out the trash to be picked up that day. Monday: Yard waste only. Tuesdays: Regular trash. Wednesday: Recycling. Thursday: None. Friday: Regular trash + 1 bulk item.

Please note: Per <u>Florida Statute 162.21</u>, anyone submitting a code violation report must provide their name and address. We cannot investigate code violation claims without this information.

ORDINANCE NO. 22-10-AN ORDINANCE OF THE CITY OF BELLE ISLE, FLORIDA, MODIFYING CHAPTER 10, "ENVIRONMENT," BY CREATING ARTICLE VII, "DILAPIDATED, DANGEROUS, DECAYED STRUCTURES AND APPURTENANCES: AMENDING SECTION 10-153 "GRASS. LANDSCAPING AND LOT MAINTENANCE; AMENDING CHAPTER 18 "PARKS AND **RECREATION"; AMENDING SECTION 24-41** "TEMPORARY CONSTRUCTION DUMPSTERS"; AMENDING SECTION 30-32 "NOTICE TO REMOVE" AND SECTION 30-36 "REMOVAL OF VEHICLE BY CITY FROM PROPERTY" OF THE CITY'S CODE OF ORDINANCES; AND PROVIDING FOR ENFORCEMENT, SEVERABILITY, CONFLICTS, CODIFICATION. AND AN EFFECTIVE DATE.

CRINKLE COOKIES

(By Heidi Peacock)

1/2 cup butter, softened

- 1 egg
- 1 teaspoon vanilla
- 1 cup flour
- 1/2 cup granulated sugar
- 1/2 cup packed light brown sugar
- 1/2 cup + 2 Tablespoons unsweetened cocoa
- powder
- 1 teaspoon baking soda
- 1/8 teaspoon salt
- 1 cup size semi-sweet chocolate chips
- 3 Tablespoons granulated sugar 1 cup confectioners' sugar

Instructions:

In a large bowl combine beat butter, granulated sugar, and brown sugar. Add egg and vanilla extract. In a separate bowl combine flour, cocoa powder, baking soda, and salt. Slowly pour the dry ingredients into the wet ingredients. Combine and add in the chocolate chips. The cookie dough will be thick and very sticky. Cover dough tightly and chill in the refrigerator for at least 3 hours or overnight. Chilling is mandatory.

Remove cookie dough from the refrigerator and allow to sit at room temperature for 10-15minutes. This makes the chilled cookie dough easier to scoop and roll.

Preheat oven to 350°F. Line large baking sheets with parchment paper or silicone baking mats. Scoop and roll balls of dough, about 2 Tablespoons of dough each, into balls. Roll each ball very lightly in granulated sugar, then generously in the confectioners' sugar. Place 3 inches apart on the baking sheets.

Bake the cookies for 11-12 minutes or until the edges appear set and the centers still look soft. Cool cookies for 5 minutes on the baking sheet, and then transfer to a cooling rack to cool completely. The cookies will slightly deflate as they cool.

Serve with a cold glass of milk or a cup of hot cocoa.

Best Nhanagement Practices

Why Are We Regulating Fertilizer Use? Many fertilizers contain nitrogen and phosphorus, also known as *nutrients*. Pollution from nutrients harms our natural waterbodies – springs, lakes and rivers – by causing algae blooms and poor water quality. How does nutrient pollution get there? When yards are over-fertilized, the excess nitrogen and phosphorus flow with rainwater into the same stormwater system designed to keep your property and roads from flooding during heavy rain. By doing something as simple as choosing fertilizer carefully and applying it properly, together we can make a big impact on the health of our natural water bodies.

Restricted Season: June 1 - September 30

No fertilizer containing nitrogen or phosphorus may be applied in Orange County from June 1 through September 30.

Rules apply to both residential and commercial fertilizer applicators. October 1 - May 31

- Applying fertilizer with phosphorus is prohibited unless a soil test shows a phosphorus deficiency in that area.
- If fertilizer with nitrogen is used, at least 65% of the nitrogen must be slow-release type.
- No more than 1 pound of total nitrogen may be applied per 1,000 square feet of landscape.
- No lawn may receive more than 3 pounds of total nitrogen per 1,000 square feet of landscape.

Year-round

- All areas of property covered by lawn, turf and landscape plants are subject to the <u>fertilizer</u> ordinance.
- Deflector shields must be in place when broadcast spreaders are used next to streets, inlets, ditches, conveyances and waterways.
- No fertilizer or grass clippings shall be deposited on streets, driveways or in storm drains.
- No fertilizer can be applied within 25 feet from waterways.
- Application sites should maintain a 10-foot low maintenance zone planted area with no fertilizing, mowing or maintenance adjacent to water bodies.
- No fertilizer shall be applied when the National Weather Service issues any advisory for severe thunderstorm, flood, tropical storm or hurricane.

What are best management practices (BMPs)?

- Best management practices (BMPs) have been determined to be effective and practical means of preventing or reducing non-point source pollution to help achieve water quality goals. BMPs include both measures to avoid pollution and to measures from mitigating pollution.
- Before draining your pool, test the water quality.
- When draining your pool, pump water at a low rate across your lawn. A recommended discharge rate of 25 gal/min or less will allow your lawn to absorb discharge water.
- In the trash after draining your pool, dispose of all filter media, such as diatomaceous earth (DE).

DON'T FLUSH MEDICATIONS

When disposing of unwanted or expired medications, do not flush them down the toilet or pour them down the drain. Instead, please bring them to one of Orange County's drop-off locations, which can be found on the EcoMap at <u>www.ocfl.net/environment</u>, or drop them off at the Belle Isle Police Department at 1521 Nela Avenue.

HOUSEHOLD AND ELECTRONIC WASTE

Help protect the environment and our health. Please don't dispose of dangerous household chemicals in your garbage, down storm drains, into sinks, or by burying them. They pose a threat to Florida's drinking water. Product labels can tip you off to a potential hazard. Look for these words: Pesticide, Warning, Caustic, Poison, Acid, Danger, or Flammable.

Household hazardous waste includes items like these:

- Paint and paint thinners
- Batteries (except alkaline/non-rechargeables)
- Fluorescent lightbulbs
- Cooking and motor oil
- Antifreeze and brake fluid
- Household cleaning fluids
- Pool chemicals, Pesticides and Propane tanks

Electronic equipment can be recycled. Many local retailers offer electronics recycling. Visit <u>Earth911</u> (<u>https://earth911.com/</u>) to search for a location by equipment type. An item is considered electronic waste if it contains a circuit board. Examples include:

- Cell phones, Computers
- Televisions Please note that rear-projection television sets cannot be recycled. Please call the waste hauler for more information.
- VCRs, CD players, and Stereos

Live Christmas trees can be set out at the curb on your yard waste collection day for recycling. Trees over six feet should be cut in half. Remove all ornaments, decorations, and stands before placing at the curb. Artificial trees are not collected with yard waste.

- Adopt rules for the conduct of proceedings
- Make a recommendation to the City Council upon any matter coming within the scope of its work, as deemed necessary.
- Prepare plans for Belle Isle's annual Arbor Day Ceremony.
- Perform any other duties assigned by the City Manager. .
